Instructions for providing chemical identity information for your pre-introduction report

You should complete this form if all of the following apply:

- You are an introducer
- You know the proper names for the chemicals in your blend
- · 2 or more chemicals to be introduced in your blend will be 'low-risk flavour or fragrance blend introductions'

You can use this form to provide identity information for up to 20 chemicals. You should upload this form with your pre-introduction report in AICIS Business Services.

Instructions for providing information about chemicals in a blend before it's first introduced

You should complete this form if all of the following apply:

- You are an introducer or the chemical identity holder for chemicals to be introduced in a flavour or fragrance blend
- You know the proper names for the chemicals in that blend
- If any of the chemicals in that blend that meet the criteria for 'low-risk flavour or fragrance blend introductions' are **not** on the IFRA Transparency List when the pre-introduction report is submitted.
- The information has not already been given to us.

You can use this form to provide information for up to 20 chemicals. You need to give us this information before the chemicals in the blend are first introduced into Australia.

You can upload this form with your pre-introduction report in AICIS Business Services (if you are the introducer). Otherwise, you can email it to **reportedintroductions@industrialchemicals.gov.au**.

1. Provide chemical identity information if there are 2 or more chemicals in your flavour or fragrance blend that meet the criteria for 'low-risk flavour or fragrance blend introductions'.

For each of these chemicals, you must fill out the information in **column 2** (proper name — CAS or IUPAC), **column 3** (CAS number — if known) and **column 4** (any other names you use to refer to your chemical).

 Provide information about any chemicals in your flavour or fragrance blend **before** they are first introduced that are not on the IFRA Transparency List when the pre-introduction report is submitted. Note: If you've already given us this information, you don't need to provide it again.

For each of these chemicals, you must fill out the information in **column 2** (proper name — CAS or IUPAC), **column 3** (CAS number — if known) and **column 5** (details of any hazard characteristics known to you). Filling out the information in column 4 is optional.

In **columns 6 and 7**, you will need to provide the concentration of the chemical in the flavour or fragrance blend, which will generally be the same at introduction and end use. You **don't** need to work out the concentration of the chemical in each type of product at end use.
